**IMPORTANT!!!**

- UN 3480, State of Charge ≤ 30%. Must not be packed with Class 1 (except Div 1.4S), Div 2.1, Class 3, Div 4.1 and Div 5.1.
- UN 3480, Section II, No BUP, No more than 1 package of cells / batteries in a consignment / an overpack.
- UN 3481, Equipment = device for which the lithium cells / batteries will provide electrical power for its operation.

**IMPORTANT!!!**

- UN 3090, Must not be packed with Class 1 (except Div 1.4S), Div 2.1, Class 3, Div 4.1 and Div 5.1.
- UN 3090, Section II, No BUP, No more than 1 package of cells / batteries in a consignment / an overpack.
- UN 3091, Equipment = device for which the lithium cells / batteries will provide electrical power for its operation.
